V. EXECUTIVE SUMMARY:

This report is a recap of the quarterly ethics hotline activity.

VI. ANALYSIS:

There were 112 reports received reported as follows:

- a. Ethics Hotline 28
- b. Management referral 36
- c. Privacy 48

Investigations were completed on 80 cases of which 64 involved suspected privacy breaches due to improper transmission out of State Fund of information including personal information of policyholders and claimants and proprietary information for unapproved business or personal use. The increase in Privacy reports represents an increase in understanding of personal identifiable information and what constitutes a breach.

VII. RECOMMENDATION:

Management works with HR or the Privacy Office to implement corrective actions and to execute any disciplinary actions.
