V. EXECUTIVE SUMMARY:

In accordance with Sections 1200 and 1201 of the California Insurance Code, all investments made during January to March of 2023 (including securities purchased or sold, and investment loans) are presented to the Investment and Risk Committee for approval.

VI. ANALYSIS:

The investment transactions for the period of January 1, 2023 to March 31, 2023 are attached as Item 3b(i). In the fixed income portfolio, State Fund purchased 77 bonds totaling \$607.5 million and sold 3 bond sales totaling \$16 million. In the equity portfolio, \$34.3 million were purchased. The total sales were \$62.6 million, which covered \$33 million from rebalancing and \$29.6 million from sell orders. Year-to-date through March 31, 2023, the total net gain from the entire portfolio was \$1.5 million. The aggregate book adjusted carrying value of all investments was approximately \$19.6 billion.

In the alternative portfolio, the total capital contribution was \$2,216,041 during this quarter. In the short-term portfolio, the year-to-date earned income was \$219,705. The total of the portfolio was \$30.1 million at the end of March.

There were no out-of-compliance items in the portfolios as of March 31, 2023

We request the Investment and Risk Committee’s approval and ratification of these investment transactions. These reports are attached as Item 6c(i) on the agenda of the Full Board meeting.

VII. RECOMMENDATION:

We recommend that the Investment and Risk Committee approve and ratify the investment transactions from January 1, 2023 to March 31, 2023.
