### V. EXECUTIVE SUMMARY:

The State Fund By-Laws are reviewed annually for potential changes. Recommendations to the Governance Committee are to be presented and approved at the May Governance Committee Open Meeting, and thereafter recommended to the full Board for adoption.

### VI. ANALYSIS:

At the November 2016 meeting, the Board adopted the Seventh Amended By-Laws to allow the Board Chair to nominate a vice chair for each Board Committee. The Seventh Amended By-Laws were approved without change at the May 2017 meeting.

This year, the Board Liaison, Legal Department, and/or Executive Committee have completed their annual review of the State Fund By-Laws, and recommend removing section 6 "Principal Office", which references the location of the Principal office. The reference to principal office in section 7 "Place of Meetings" is to be deleted, as well; instead the location to be referenced is "a State Fund Office". In section 8 "Regular Meetings", it is recommended that the Chairperson of the Board approve a date change of a regularly scheduled meeting, rather than requiring a majority of voting members present at a meeting to vote on advancing or postponing the date of a meeting. In section 9 "Special and Emergency Meetings", it is recommended that "a State Fund office" replace the "principal office of State Fund". In section 17 "Standing Committees", the "Investment Committee" name has been updated to the "Investment and Risk Committee". In section 32, non-substantive changes were made to reconcile the language with earlier sections.

# VII. RECOMMENDATION:

To approve the Eighth Amended State Fund By-Laws as presented.

1. <u>Name, Organization and Purpose</u>. These Eighth Amended and Restated By-Laws ("By-laws") are intended to supplement California Insurance Code Section 11770 <u>et seq</u>., as may be amended from time to time (hereinafter referred to as the "Insurance Code"). Wherever in these By-laws the name "State Fund" is used, it shall mean State Compensation Insurance Fund of the State of California; and wherever "Board" or "Board of Directors" is used, it shall mean the Board of Directors of State Fund.

2. <u>Governing Authority</u>. All powers of the Board shall be exercised pursuant to and in compliance with the authority provided in Division 2, Part 3, Chapter 4 (Section 11770 <u>et seq</u>.) of the California Insurance Code (hereinafter referred to as the "Insurance Code"), as may be amended from time to time.

All Board proceedings and deliberations shall comply with the provisions of the Bagley-Keene Open Meeting Act, California Government Code Section 11120 <u>et seq</u>., as may be amended from time to time (hereinafter referred to as the "Bagley-Keene Act").

3. <u>Board Membership</u>. The Board is composed of up to eleven voting members (hereinafter referred to as the "Voting Members") who shall be appointed and shall serve in such capacity in accordance with Insurance Code Section 11780, as may be amended from time to time. The Director of Industrial Relations shall be an ex officio, non-voting member of the Board (hereinafter referred to as the "Non-Voting Member"). Wherever in these By-laws the term "members" is used, it shall mean the Voting Members and the Non-Voting Member. 4. <u>Term of Office</u>. The terms of office of the Voting Members shall be as specified in Section 11770 of the Insurance Code, as may be amended from time to time, and the Voting Members shall hold office until the appointment and qualification of their successors.

5. <u>Chairperson</u>. As provided in Section 11770 of the Insurance Code, as may be amended from time to time, the Governor shall appoint the Chairperson of the Board (the "Chairperson"). The Chairperson may, at the Chairperson's discretion, appoint a Vice Chairperson from among the Voting Members.

The Chairperson shall preside at all meetings of the Board. Subject to the direction of the Board, the Chairperson shall generally manage the business and affairs of the Board and perform such other duties as assigned by the Board. In the absence or disability of the Chairperson, if any, shall assume the duties of the Chairperson. In the absence or disability of the Vice Chairperson, the Voting Member present at a meeting of the Board, holding the longest consecutive term of service as a member of the Board, shall preside at such meeting of the Board.

6. <u>Principal Office</u>. The principal office of State Fund is located in the City and County of San Francisco, California or at such other location as the Board shall determine.

7. <u>Place of Meetings</u>. State Fund shall hold its regular and special Board meetings at a Regular and special meetings of the Board shall be held at the principal office of State Fund office, or at such other place as shall be designated, as set forth in the notice of the meeting.

8. <u>Regular Meetings</u>. Regular meetings of the Board shall be held at least four times each calendar year on such dates and at such times as may be determined from time to time by the Board. With the approval of the Chairperson of the Board <u>a majority of the Voting Members</u> present at a meeting, any scheduled regular meeting may be advanced or postponed to another date.

9. <u>Special and Emergency Meetings</u>. Special and emergency meetings of the Board may be called pursuant to the provisions of the Bagley-Keene Act and shall be held at the principal office of a State Fund office or at such other place as shall be designated in the notice of the meeting.

10. <u>Notice of Special and Emergency Meetings</u>. Notice of the time and place of special and emergency meetings of the Board shall comply with the provisions of the Bagley- Keene Act.

11. <u>Closed Sessions</u>. Closed sessions of the Board may be held at any regular, special, or emergency meeting pursuant to the provisions of the Bagley-Keene Act.

12. <u>Adjournment</u>. A majority of the Voting Members present, whether or not constituting a quorum, may adjourn any meeting to another time and place.

13. <u>Notice of Adjournment</u>. Notice of the time and place of holding an adjournment meeting shall be provided in compliance with the provisions of the Bagley-Keene Act.

14. <u>Attendance</u>. Attendance of Board members at regular, special, or emergency meetings may be by conference telephone, electronic video screen communication or electronic transmission in compliance with the provisions of the Bagley-Keene Act, if all members of the

Board participating in the meeting can hear each other at the same time. Participation in a meeting by these means shall constitute presence in person at the meeting.

15. <u>Quorum</u>. A majority of the appointed number of Voting Members shall constitute a quorum for the transaction of business, except to adjourn as herein provided; at no time shall a quorum be established with less than five Voting Members. Every act or decision done or made by a majority of the Voting Members present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board.

16. <u>Committees of the Board</u>. The Board may, by resolution adopted by a majority of the Voting Members present at a meeting duly held at which a quorum is present, designate one or more committees to serve at the pleasure of the Board. Each committee of the Board shall consist of three or more Voting Members.

Each committee shall have the responsibilities and authority as designated from time to time by resolution of the Board, a Board-approved committee charter, or as otherwise prescribed by applicable law, including the ability to delegate to a subcommittee of a committee, with Board approval, except with respect to:

(a) the filling of vacancies on the Board or in any committee;

(b) the amendment or repeal of the By-laws or the adoption of new By-laws;

(c) the amendment or repeal of any resolution of the Board which by its express terms is not so amendable or repealable; or

(d) the appointment of any other committees of the Board or the members thereof.

17. <u>Standing Committees</u>. The standing committees of the Board of Directors shall be: (a) the Audit Committee, (b) the Investment and Risk Committee, (c) the Governance Committee and (d) any other committees the Board determines are necessary.

18. <u>Ad Hoc Committees</u>. In addition to the standing committees of the Board of Directors, the Board may, by resolution adopted by a majority of the Voting Members present at a meeting duly held at which a quorum is present, designate one or more <u>ad hoc</u> committees.

19. <u>Committee Appointments</u>. In accordance with all legal and other applicable requirements, the Chairperson shall nominate the chair, vice chair, members, and alternate members of any committee of the Board. In any instance in which the Chairperson nominates a person to a currently-held position as chair, vice chair, member or alternate member, the Chairperson's nomination shall be deemed to be a nomination to replace the current chair, vice chair, member or alternate member. The Chairperson's nominations shall be reviewed and approved by the Corporate Governance Committee, and thereafter ratified by a majority of the Voting Members present at a meeting duly held at which a quorum is present. A duly-appointed alternate member of a committee may replace any absent member at any meeting of a committee.

20. <u>Resignation of Committee Members</u>. Any committee member may resign at any time by giving written notice thereof to the Chairperson or the Secretary. Any such resignation shall take effect on the date of receipt of such notice by one of the above-specified officers, or at

such later time specified therein, and, unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective.

21. <u>Removal of Committee Members</u>. Any committee member may be removed at any time and for any reason by the Chairperson or by a majority of the Voting Members present at a meeting duly held at which a quorum is present.

22. <u>Committee Vacancies</u>. Vacancies in any committee, including vacancies in the chair of a committee, howsoever and whenever arising, may be filled by the Chairperson, subject to the ratification by a majority of the Voting Members present at the next Board meeting duly held following such appointment at which a quorum is present.

23. <u>Meetings and Action of Committees</u>. Meetings and actions of committees shall be governed by, and held and taken in accordance with, the provisions of these By-laws, with such changes in the context of the By-laws as are necessary to substitute the respective committee and its members for the Board of Directors and its members. The Board of Directors may adopt rules for the governance of any committee not inconsistent with the provisions of these By-laws and with the provisions of the Bagley-Keene Act.

24. <u>Minutes</u>. Minutes shall be kept of all regular, special and emergency Board and committee meetings, and shall show the names of the members who are present and a succinct statement of each matter brought before the Board for consideration together with a record of the votes thereon.

25. <u>Secretary and Assistant Secretary</u>. The Voting Members shall elect, by majority vote at a meeting duly held at which a quorum is present, a person to serve as Secretary of State Fund. The Secretary shall attend all meetings of the Board and its committees, and be responsible for the keeping of proper minutes of such meetings. The Secretary will be the custodian of the minutes and the records of the Board, and will perform such other duties as may be assigned to him or her from time to time. The Voting Members may also elect one or more persons to serve as Assistant Secretary. In the absence of the Secretary, the Assistant Secretary shall assume the duties, and perform the responsibilities of, the Secretary. In the absence of the Secretary or an Assistant Secretary, the Chairperson shall designate a Secretary, pro tem.

26. <u>Officers</u>. The officers of State Fund are: (1) the President; (2) the positions appointed by the Board pursuant to the powers and duties specified in Insurance Code Section 11785; (3) any members of the Executive Committee not otherwise listed herein; and, (4) any such other officers as the affairs of State Fund may require, each of whom shall hold office for such period, have such authority, and perform such duties and assume such responsibilities, as the President may from time to time prescribe. The President shall apprise the Board from time to time as to the current officers of State Fund and their respective duties and responsibilities.

27. <u>President</u>. The President of State Fund shall manage and conduct the business and affairs of State Fund under the general direction, and subject to the approval of, the Board of Directors, and shall also perform such other duties as the Board prescribes. The President shall have the powers and duties conferred by law. The Board may delegate to the President any additional power, function or duty conferred by law on the Board in connection with the administration, management, and conduct of the business and affairs of State Fund. The President may exercise those powers with the same force and effect as the Board. In the absence or disability of the President, the Board may designate any other officer of State Fund, as defined by Section 26, to perform the duties of the President.

28. <u>Removal of Officers</u>. The President may, at any time, remove the designation as an officer of State Fund from any person previously designated as such, except for those persons appointed by the Board pursuant to Insurance Code Section 11785, and whether such designation as an officer was obtained by operation of the By-laws or by action of the President. A majority of the Voting Members present at a meeting duly held at which a quorum is present, may remove the designation as an officer of State Fund from any person designated as such, whether such designation was obtained by operation of the By-laws or by action of the President. Notwithstanding any such removal, the continued employment by State Fund of any officer so removed shall be governed exclusively by applicable law and without prejudice to the rights and obligations, if any, then existing under such law.

29. <u>Resignation of Officers</u>. Any officer may resign at any time by giving written notice to the Board, the Chairperson, or the Secretary. Any such resignation shall take effect at the date of the receipt of such notice or at any later time specified therein; and unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective. Any resignation is without prejudice to the rights, if any, of State Fund under any contract to which the officer is a party. Notwithstanding any such resignation, the continued employment by State Fund of any officer who has resigned shall be governed exclusively by applicable law and without prejudice to the rights and obligations, if any, then existing under such law.

30. <u>Inspection by the Board of Directors</u>. Every member of the Board shall have the absolute right at any reasonable time to inspect all books, records, and documents of every kind, and the physical properties of State Fund. This inspection by a member of the Board may be made in person or by an agent or attorney of such member, and the right of inspection includes the right to copy and make extracts of documents. The rights to inspect and copy are subject to, and may be circumscribed in, instances where such rights conflict with California or federal law pertaining to access to, or possession of, books, records and documents.

31. <u>Liability of Members, Officers and Other Agents; Indemnification of Members,</u> <u>Officers and Other Agents</u>.

(a) <u>Liability of Members, Officers and Other Agents</u>. The liability, in a private capacity, of any Board member, officer or other agent of State Fund shall be circumscribed by Insurance Code Section 11772.

(b) Indemnification - Third Party Proceedings. Notwithstanding Section 31(a), in these By-laws or herein, State Fund shall indemnify any person (each, an "Indemnitee") who is or was a party or is threatened to be made a party to any proceeding (other than an action by or in the right of State Fund to procure a judgment in its favor) by reason of the fact that Indemnitee is or was (i) a member, or (ii) an officer as defined in Section 26 herein, by reason of any action or inaction on the part of Indemnitee while a member or officer against actual and reasonable expenses (including subject to Section 31(f), attorneys' fees and any expenses of establishing a right to indemnification pursuant to Section 31 or under California law), judgments, fines, settlements (if such settlement is approved in advance by State Fund, which approval shall not be unreasonably withheld) and other amounts actually and reasonably incurred by Indemnitee in connection with such proceeding if Indemnitee acted in good faith and in a manner Indemnitee reasonably believed to be in, or not opposed to, the best interests of State Fund and, in the case of a criminal proceeding, if

Indemnitee had no reasonable cause to believe Indemnitee's conduct was unlawful. The termination of any proceeding by judgment, order, settlement, conviction, or upon a plea of <u>nolo contendere</u> or its equivalent, shall not, of itself, create a presumption that Indemnitee did not act in good faith and in a manner which Indemnitee reasonably believed to be in, or not opposed to, the best interests of State Fund, or with respect to any criminal proceedings, would not create a presumption that Indemnitee had reasonable cause to believe that Indemnitee's conduct was unlawful.

Indemnification - Proceedings by or in the Right of State Fund. State Fund (c) shall indemnify Indemnitee if Indemnitee was or is a party or is threatened to be made a party to any threatened, pending or completed action by or in the right of State Fund to procure a judgment in its favor by reason of the fact that Indemnitee is or was a member or officer by reason of any action or inaction on the part of Indemnitee, while a member or officer, against expenses (including subject to Section 31(f) herein, actual and reasonable attorneys' fees and expenses of establishing a right to indemnification, pursuant to Section 31 or under California law), and, to the fullest extent permitted by law, amounts paid in settlement, in each case to the extent actually and reasonably incurred by Indemnitee, in connection with the defense or settlement of the proceeding, if Indemnitee acted in good faith and in a manner Indemnitee believed to be in, or not opposed to, the best interests of State Fund, except that no indemnification shall be made with respect to any claim, issue or matter to which Indemnitee shall have been adjudged to have been liable to State Fund in the performance of Indemnitee's duty to State Fund, unless and only to the extent that the court, in which such proceeding is or was pending, shall determine upon application that, in view of all the circumstances of the case, Indemnitee is fairly and reasonably entitled to indemnity for expenses and then only to the extent that the court shall determine.

(d) <u>Successful Defense on Merits</u>. To the extent that Indemnitee, without limitation, has been successful on the merits in defense of any proceeding referred to in Sections 31(b) or 31(c) herein or in defense of any claim, issue or matter therein, State Fund shall indemnify Indemnitee against expenses (including attorneys' fees) actually and reasonably incurred by Indemnitee in connection therewith.

(e) <u>Certain Terms Defined</u>. For purposes of Section 31 herein, references to "proceeding" shall include any threatened, pending or completed action or proceeding, whether civil, criminal, administrative or investigative.

(f) <u>Advancement of Expenses</u>. State Fund shall advance all actual and reasonable expenses incurred by Indemnitee in connection with the investigation, defense, settlement (excluding amounts actually paid in settlement of any action, suit or proceeding) or appeal of any civil or criminal action, suit or proceeding referenced in Sections 31(b) and (c) herein. Indemnitee hereby undertakes to repay such amounts advanced only if, and to the extent that, it shall be determined ultimately that Indemnitee is not entitled to be indemnified by State Fund as authorized hereby. The advances to be made hereunder shall be paid by State Fund to Indemnitee within twenty (20) days following delivery of a written request therefor by Indemnitee to State Fund.

(g) <u>Notice of Claim</u>. Indemnitee shall, as a condition precedent to his or her right to be indemnified under Section 31 herein, give State Fund notice in writing as soon as practicable of any claim made against Indemnitee for which indemnification will or could be sought under Section 31. Notice to State Fund shall be directed to the Secretary at the principal office of State Fund (or such other address as State Fund shall designate in

writing to Indemnitee). In addition, Indemnitee shall give State Fund such information and cooperation as it may reasonably require and as shall be within Indemnitee's power.

Enforcement Rights. Any indemnification provided for, in Sections 31(b), (h) 31(c) or 31(d) herein, shall be made no later than sixty (60) days after receipt of the written request of Indemnitee. If a claim or request under Section 31 or under any statute providing for indemnification is not paid by State Fund, or on its behalf, within sixty (60) days after written request for payment thereof has been received by State Fund, Indemnitee may, but need not, at any time thereafter bring suit against State Fund to recover the unpaid amount of the claim or request, and subject to Section 31(r), Indemnitee shall also be entitled to be paid for the expenses (including actual and reasonable attorneys' fees) of bringing such action. It shall be a defense to any such action (other than an action brought to enforce a claim for expenses incurred in connection with any action, suit or proceeding in advance of its final disposition) that Indemnitee has not met the standards of conduct which make it permissible under applicable law for State Fund to indemnify Indemnitee for the amount claimed, but the burden of proving such defense shall be on State Fund, and Indemnitee shall be entitled to receive interim payments of expenses pursuant to Section 31(f) unless and until such defense may be finally adjudicated by court order or judgment for which no further right of appeal exists. The parties hereto intend that if State Fund contests Indemnitee's right to indemnification, the question of Indemnitee's right to indemnification shall be a decision for the court, and no presumption regarding whether the applicable standard has been met will arise based on any determination or lack of determination of such by State Fund (including its Board or independent legal counsel).

Assumption of Defense. In the event State Fund is obligated to pay the (i) expenses of any proceeding against Indemnitee, State Fund shall be entitled to assume the defense of such proceeding with counsel approved by Indemnitee, which approval shall not be unreasonably withheld, upon delivery to Indemnitee of written notice of its election to do so. After delivery of such notice, approval of such counsel by Indemnitee and the retention of counsel by State Fund, State Fund will not be liable to Indemnitee under Section 31 herein for any fees of counsel subsequently incurred by Indemnitee with respect to the same proceeding, unless (i) the employment of counsel by Indemnitee has been previously authorized by State Fund, (ii) Indemnitee shall have reasonably concluded, based on written advice of counsel, that there may be a conflict of interest of such counsel retained by State Fund between State Fund and Indemnitee in the conduct of such defense, or (iii) State Fund ceases or terminates the employment of such counsel with respect to the defense of such proceeding, in any of which events the fees and expenses of Indemnitee's counsel shall be at the expense of State Fund. At all times, Indemnitee shall have the right to employ other counsel in any such proceeding at Indemnitee's expense.

(j) <u>Approval of Expenses</u>. No expenses for which indemnity shall be sought under Section 31 herein, other than those with respect to judgments and verdicts actually rendered, shall be incurred without the prior consent of State Fund, which consent shall not be unreasonably withheld.

(k) <u>Subrogation</u>. In the event of payment under Section 31 herein, State Fund shall be subrogated to the extent of such payment to all of the rights of recovery of the Indemnitee, who shall do all things that may be necessary to secure such rights, including the execution of such documents necessary to enable State Fund effectively to bring suit to enforce such rights.

(I) <u>Exceptions</u>. Notwithstanding any other provision herein to the contrary, State Fund shall not be obligated pursuant to Section 31 herein:

(i) <u>Excluded Acts</u>. To indemnify Indemnitee (a) as to circumstances in which indemnity is expressly prohibited pursuant to California or Federal law, or (b) for any acts or omissions or transactions from which person may not be relieved of liability pursuant to California or Federal law; or

(ii) <u>Claims Initiated by Indemnitee</u>. To indemnify or advance expenses to Indemnitee with respect to proceedings or claims initiated or brought voluntarily by Indemnitee and not by way of defense, except with respect to proceedings brought to establish or enforce a right to indemnification under this Section 31 or any other statute or law but such indemnification or advancement of expenses may be provided by State Fund in specific cases if the Board has approved the initiation or bringing of such suit; or

(iii) <u>Lack of Good Faith</u>. To indemnify Indemnitee for any expenses incurred by the Indemnitee with respect to any proceeding instituted by Indemnitee to enforce or interpret Section 31 herein, if a court of competent jurisdiction determines that such proceeding was not made in good faith or was frivolous; or

(iv) <u>Insured Claims</u>. To indemnify Indemnitee for expenses or liabilities of any type whatsoever (including, but not limited to, judgments, fines, or penalties, and amounts paid in settlement) which have been paid directly to Indemnitee by an insurance carrier under a policy of liability insurance maintained by State Fund.

(m) <u>Partial Indemnification</u>. If Indemnitee is entitled under any provision of Section 31 herein to indemnification by State Fund for some or a portion of the expenses, judgments, fines, or penalties actually or reasonably incurred by the Indemnitee in the investigation, defense, appeal or settlement of any civil or criminal action, suit or proceeding, but not, however, for the total amount thereof, State Fund shall nevertheless indemnify Indemnitee for the portion of such expenses, judgments, fines or penalties to which Indemnitee is entitled.

(n) <u>Coverage</u>. Section 31 herein shall, to the extent permitted by law, apply to acts or omissions of Indemnitee which occurred prior to the adoption of Section 31 if Indemnitee was a member or officer of State Fund at the time such act or omission occurred. All rights to indemnification under Section 31 shall be deemed to be provided by a contract between State Fund and the Indemnitee in which State Fund hereby agrees to indemnify Indemnitee to the fullest extent permitted by law, notwithstanding that such indemnification is not specifically authorized by these By-laws or by statute. Any repeal or modification of these By-laws or any applicable law shall not affect any rights or obligations then existing under Section 31. The provisions of Section 31 shall continue as to Indemnitee for any action taken or not taken while serving in an indemnified capacity even though the Indemnitee may have ceased to serve in such capacity at the time of any action, suit or other covered proceeding. Section 31 shall be binding upon State Fund and its successors and assigns and shall inure to the benefit of Indemnitee and Indemnitee's estate, heirs, legal representatives and assigns.

(o) <u>Non-Exclusivity</u>. Nothing herein shall be deemed to diminish or otherwise restrict any rights to which Indemnitee may be entitled under these By-laws, any agreement or under the laws of the State of California.

(p) <u>Severability</u>. Nothing in Section 31 herein is intended to require or shall be construed as requiring State Fund to do or fail to do any act in violation of applicable law. If Section 31 or any portion hereof shall be invalidated on any ground by any court of competent jurisdiction, then State Fund shall nevertheless indemnify Indemnitee to the fullest extent permitted by any applicable portion of Section 31 that shall not have been invalidated.

(q) <u>Attorneys' Fees</u>. In the event that any action is instituted by Indemnitee under Section 31 herein to enforce or interpret any of the terms hereof, Indemnitee shall be entitled to be paid all court costs and expenses, including reasonable attorneys' fees incurred by Indemnitee with respect to such action, unless as a part of such action, the court of competent jurisdiction determines that the action was not instituted in good faith or was frivolous. In the event of an action instituted by or in the name of State Fund under Section 31, or to enforce or interpret any of the terms of Section 31, Indemnitee shall be entitled to be paid all court costs and expenses, including reasonable attorneys' fees, incurred by Indemnitee in defense of such action (including with respect to Indemnitee's counter-claims and cross-claims made in such action), unless as a part of such action the court determines that Indemnitee's defenses to such action were not made in good faith or were frivolous.

(r) <u>Notice</u>. All notices, requests, demands and other communications under Section 31 herein shall be in writing and shall be deemed duly given (i) if delivered by hand and receipted for by the addressee, on the date of such receipt, (ii) if sent by electronic transmission by State Fund, at the time sent, or (iii) if mailed by domestic certified mail, with postage prepaid, return receipt requested, on the third business day after the date postmarked.

32. <u>Amendment to By-Laws</u>. The Voting Members shall have the authority to repeal, alter or amend these By-laws or adopt new By-laws at any regular meeting by the affirmative vote of a majority vote of the appointed number of Voting Members at a meeting duly held, provided that at which a quorum is present, and the Voting Members shall not make or alter any By-law fixing Board membership, term of office, or qualification for Board membership, unless such amendment thereof is necessary to make these By-law provisions consistent with the laws of California.

Whenever an amendment or new By-law is adopted, it shall be placed in State Fund's book of minutes and proceedings with the By-laws. If any By-law is repealed, the fact of repeal with the date of the meeting at which the repeal was enacted shall be stated in such book of minutes and proceedings.
