V. EXECUTIVE SUMMARY:

Compliance reporting includes: Conflict of Interest Code Approval, regulatory reporting testing results and updated reporting catalog, compliance training report, and benchmark of the ethics hotline.

VI. ANALYSIS: The following summarizes compliance related activity for the period and is in alignment with the Compliance Model¹:

Clear Written Standards of Conduct, Policies & Procedures
2015 Conflict of Interest Code Approved

This is a follow-up to the May, 2015 report.

The Fair Political Practices Commission approved State Fund's Conflict of Interest Code (Code) and submitted it to the Office of Administrative Law on October 28, 2015. It became effective 30 days later, on November 27, 2015.

Announcement about the new Code was made to the organization November 25, 2015.

Operational Impact: (1) Employees and consultants must review the Code for disclosure category changes before filing their annual 2015 Statement of Economic Interests in March 2016.

(2) State Fund should amend the Conflict of Interest Code section for its 2016 Master Services Agreement to reflect the effective date of the Code.

2015 Own Risk and Solvency Assessment (ORSA) Report Submitted

State Fund submitted its ORSA report, as attested by the Chief Risk Officer, to the California Department of Insurance on November 27, 2015².

As allowed under the Insurance Code³, the ORSA report will be referenced in State Fund's Corporate Governance Annual Disclosure due June 30, 2016.

2015 Goal: Achieve 98 percent Workforce compliance rate (100 percent consultants and 98 percent employee) for the organization's mandatory training. System and building access for the outstanding 1.3 percent non-compliant consultants (three) was disabled pending training completion.

Consistent Monitoring, Evaluation & Reporting 2015 Regulatory Reporting Compliance Testing

Regulatory Reporting phase two compliance testing was completed in November 2015.

Findings: (1) State Fund meets regulatory requirements for medium and low risk reports; (2) The new *Corporate Governance Annual Disclosure* was added to the reporting catalog; and (3) one report was retired. The Workers' Compensation Insurance Rating Bureau no longer requires transmission of a United States Longshore and Harbor report.

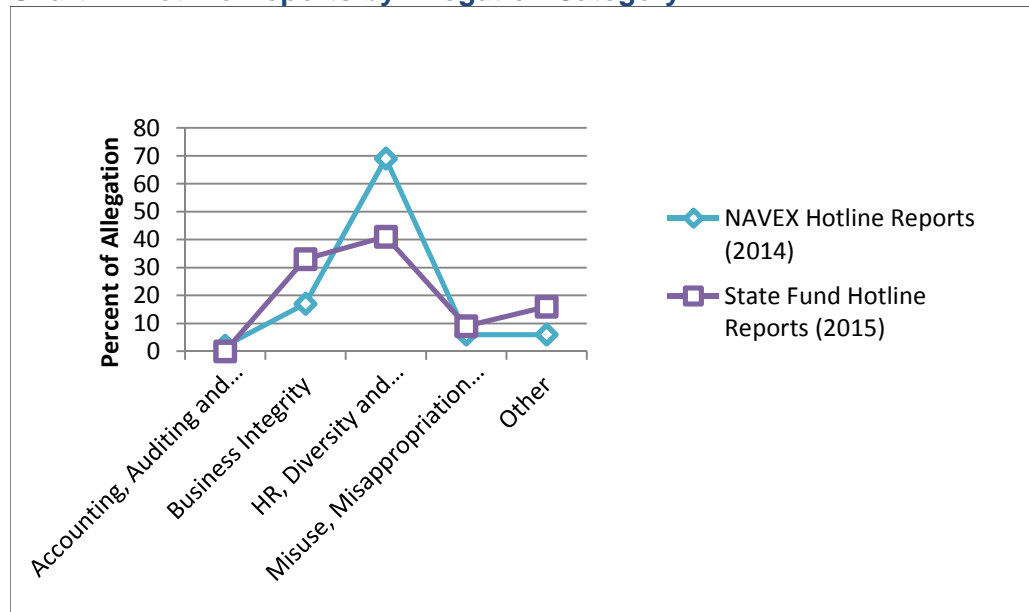

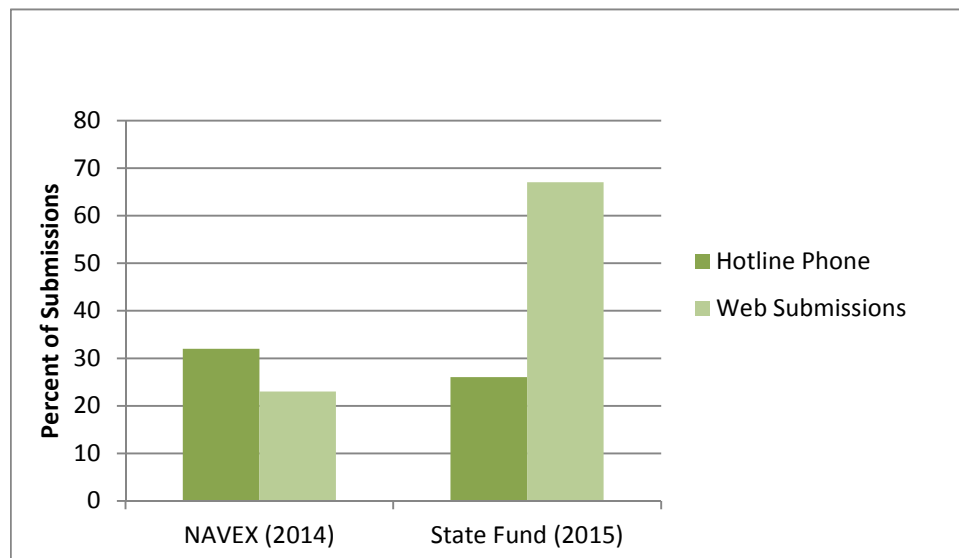
Benchmarking report: *Navex Global. 2015 Ethics and Compliance Hotline Benchmark report.*

Chart 1: Hotline Reports by Allegation Category



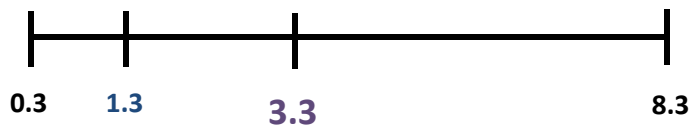
There are no significant deviations in the reporting allegation distribution between the Navex Benchmark report and State Fund hotline reports.

Chart 2: Report Intake Methods



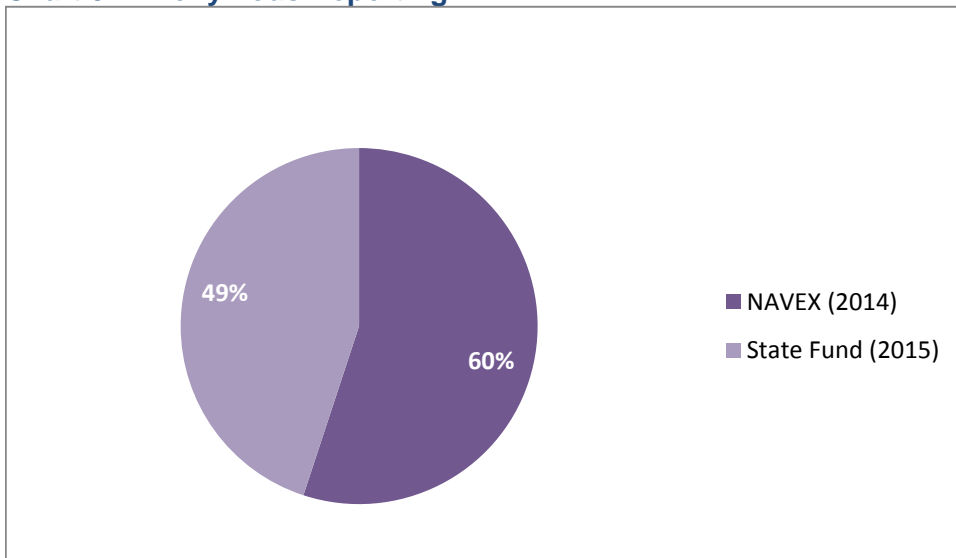
The Navex data from 2014 shows phone calls as the preferred reporting methodology. In 2015, it appears State Fund employees have found it significantly more convenient to report online.

Figure 1: Hotline Report Volume by 100 Employees



NAVEX reported minimum frequency of 0.3 reports per 100 employees and a maximum of 8.3. The Benchmark's median report frequency per 100 employees was 1.3. State Fund received an average of 3.3 reports per 100 employees. State Fund reporting frequency may be attributed to employees' awareness of what and how to report concerns and the periodic reminders that the process is available.

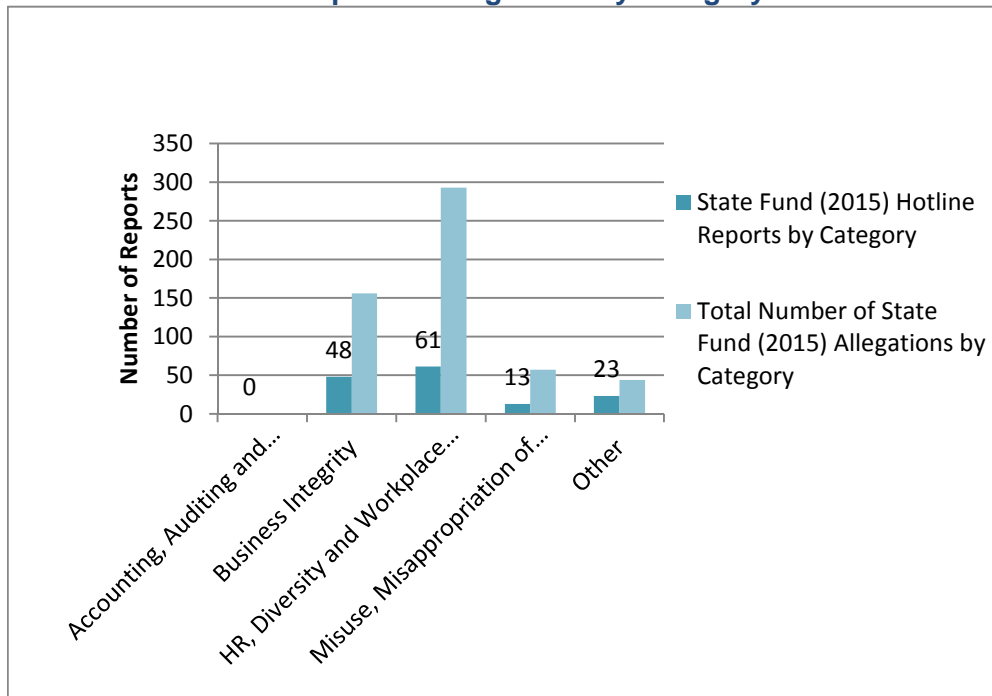
Chart 3: Anonymous Reporting



The State Fund anonymous reporting rate of 49 percent is lower than the benchmark report of 60 percent. There may be a growing comfort level by employees with reporting to the confidential hotline.
