2013 Schedule Proposal

There are 5 meetings on calendar with agenda items for 4 meetings. At the August 16, 2012 Governance and Board meetings, it was recommended to expand the length of meetings from 2 days to 3 days to allow more time for the Governance and Audit Committee meetings and discussion. The Audit Committee will meet on Wednesday and Governance Committee will meet first thing Thursday morning. There are no changes to the Investment Committee and Board meeting schedules. At the October 5, 2012 Strategic meeting, it was recommended to add an additional day to the August 2013 meeting for Strategic Planning. The March 2013 meeting is a placeholder for Board Continuing Education. If the Board determines at the prior meeting that there is time sensitive business to discuss, the additional dates in March will proceed as a meeting in lieu of Board Continuing Education.
