#### VI. ANALYSIS:

#### Review of 2019 Committees and Expansion of Investment Committee:

State Fund has a strong Board with diverse experience and background. The Board has been doing an excellent job in its strategic oversight of the State Fund to ensure fair pricing for California employers, best outcomes for injured workers and their employers and bringing safe work practices to California businesses. The Board Committee appointments have been evaluated for Board member experience and interest. The continuity of the committee membership supports the Board's effectiveness; therefore, minimal changes are proposed.

In recognition of evolving risk issues, the Board in the November 2017 meeting expanded the Investment Committee into an Investment and Risk Committee with oversight of State Fund's investment strategy, enterprise risk management, and cybersecurity.
