**V. EXECUTIVE SUMMARY:**

In accordance with Sections 1200 and 1201 of the California Insurance Code, all investments made during January to March of 2018 (including securities purchased or sold, and investment loans) are presented to the Investment Committee for approval.

**VI. ANALYSIS:**

The investment transactions for the period of January 1, 2018 to March 31, 2018 are attached as Item 3b(i). In the fixed income portfolio, State Fund purchased 80 bonds totaling \$676 million and sold 4 bonds for a total of \$29 million. In the equity portfolio, \$176 million were purchased. Year-to-date through March 31, 2018, the total net gain from the entire portfolio was \$14 million. The aggregate book adjusted carrying value of all investments was approximately \$19.8 billion.

The current investments no longer in compliance with State Fund’s Investment Policy are listed in the Compliance Report, Attachment 3b(ii). There are three out-of-compliance bonds. These bonds complied with the Investment Policy and met certain minimum credit rating standards at the time of purchase.

We request the Investment and Risk Committee’s approval and ratification of these investment transactions. These reports are also attached as Item 27ci on the agenda of the Full Board meeting.

**VII. RECOMMENDATION:**

We recommend that the Investment and Risk Committee approve and ratify the investment transactions from January 1, 2018 to March 31, 2018.
