MINUTES OF OPEN SESSION MEETING

February 19, 2015

The Governance Committee met on February 19, 2015 at the State Fund Corporate Office, 333 Bush Street, 7th floor, San Francisco, California.

AGENDA ITEM 1: ROLL CALL

Mr. Mulryan called attention to and requested confirmation that the Governance Committee members read State Fund's Antitrust Admonition, which is included in each Committee member's meeting materials.

Mr. Mulryan noted that there is no approval of an action for item 3b, "Board Member Upcoming Speeches, Articles or Webinars". Mr. Mulryan asked whether any Board member had any comments on the items on the Consent Calendar, of which there were none.

AGENDA ITEM 4: GOVERNANCE, COMPLIANCE AND PRIVACY UPDATE

Governance, Compliance & Privacy Program Manager Barbara Simmons reported on the following:

2015 Code of Conduct and Supporting Policies

Ms. Simmons reported that as part of the 2014 Compliance Plan, the Code of Conduct and its supporting policies were reviewed. Policy and Code revisions align with current law and respond to employee and manager feedback and ethics/privacy topics that were raised during 2014. The 2015 revisions include State Fund's revised Vision, a simplified Ethics Decision Tree, general revisions to all Code sections in support of trust, focus on the individual, and improved tone and readability. The following policies were reviewed and the following policy revisions are recommended:

- <u>Equal Employment Opportunity</u> protected group definition expanded to include military or veteran status
- <u>Sexual Harassment Prevention</u> added abusive conduct prevention as a component of training for managers and supervisors
- Non-Business Use of State Fund Facilities aligns with State Fund's corporate social responsibility strategy; expanded the policy to allow State Fund to officially recognize charitable activities in addition to "Our Promise: California State Employees Giving at Work".

Ms. Simmons further reported that Code of Conduct training will take place in the next two months in order to increase awareness of the importance of data privacy. Privacy messaging to the organization is ongoing to improve privacy awareness and protection of private information.

To recommend to the Board of Directors approval of the Code of Conduct and supporting policies as presented.

Compliance

Ms. Simmons reported that regulatory reporting compliance testing was completed for reports carrying penalties or fines for non-compliance or late filing. The reports of this type were adequately controlled and monitored by business owners.

Ethics and Privacy Reports

Ms. Simmons reported that Human Resources and Privacy incident reports continue to be the main reported 2014 topics. The Human Resources reports include suspected conflicts of

interest, discrimination, misuse/theft of time or funds, misconduct, and retaliation. The majority of suspected privacy incidents were internal and preventable.
